Nature of Work in this Class

The Certified Medication Aide role is to assist the licensed nurse (RN or LPN/LVN) in providing safe ethical care for clients. This will include administering prescribed drugs and completing other delegated nursing tasks allowed by state law.

Essential Functions

- Dispense oral, over the counter, inhalation and topical medications to patients under supervision of a licensed nurse or per State law;
- Observe patients for drug interactions and report any problems to the nurse;
- Performing tasks associated with the medication administration, including patient vital signs, calculate medication dosages and stock the medication cart;
- Recording medication administration according to agency procedure;
- Assists the nurse in providing care to clients, which includes observation and reporting of client needs;
- Performs tasks in an ethical, legal, and caring manner;
- Performs tasks safely and effectively to assure client comfort and welfare;
- Respects client's rights;
- Protects confidential client information unless otherwise required to promote client safety and welfare;
- Follows federal, state, and agency regulations to protect own health and that of others;
- Seeks guidance from the nurse as needed to perform tasks safely and efficiently; and
- Performs all other duties as required.
