## Nature of Work in this Class

This position provides direct service to residents, maintains case records and supervises resident activities. The Mental Health Counselor is directly responsible for initiating, implementing and documenting individual and group treatment/habilitation services as they relate to the resident's individualized treatment plan objectives. Work is supervised by the Clinical Supervisor.

### Essential Functions

- Provides assessment of residents' needs/risks to determine treatment plans.
- Use of expressive therapies a plus.
- Collaborate with care coordinators, PCP's, psychiatrists, and other professionals involved with treatment of the client.
- Keeping records and using reporting tools. (Therapy Notes)
- Manages all aspects of individual caseload and individual case records and program records as assigned.
- Develops and maintains treatment plans and services for better management of care.
- Diagnoses and treatment of mental and emotional disorders according to DSM-5
- Develops release plans, transitions to other service providers and termination letters.
- Participate and run group therapy
- Monitors, evaluates and documents progress for client.
- DAF, Ohio Scales, Mental Health Status Report, Suicide scales.
- Work well with team approach
- Performs intake procedures for new residents
- Apply Behavior Management System to manage residents' behaviors
- Performs crisis intervention services
- Prepares written reports.
- Attends staff meetings and other related meetings as required.
- Develops and maintains effective working relationships with various treatment facilities and with the general public
- Makes court appearances as designated.
- Maintains strict confidentiality with respect to information obtained and processed in the operation of the facility.
- Conducts home and/or employment visits if needed.
- Transports residents to community resources as needed.

· Supplements facility coverage – subject to being called into work at any time due to

emergency situations and/or coverage needs.
